CW16/1 MERGING OF COUNCIL'S ENTERPRISE REPORTING SYSTEMS (ID16/1929)

The Committee recommends:

- 1. That public tenders not be invited for the merging of Council's Enterprise Reporting Systems in accordance with Section 55 (3)(i) of the Local Government Act, 1993, as it is considered that a satisfactory result would not be achieved by Council due to the extenuating circumstances that there is an unavailability of competitive tenderers due to Civica Pty Ltd being the sole provider of services to the product Authority.
- 2. That Civica Pty Ltd by engaged to undertake the merger of the former Dubbo and Wellington councils' Authority and TRIM records management systems into a single integrated system, at an estimated contract amount of \$776,420 ex GST.
- 3. That IPlatinum be engaged to provide data merger and contract management support to Council, for an estimated amount of \$100,000 ex GST.
- 4. That the costs of merging the Authority and TRIM systems be funded from the New Council Merger Implementation Fund.
- 5. That any necessary documents be executed under the Common Seal of the Council.
- 6. That the documents and considerations in regard to this matter remain confidential to Council.

 - Property owners of 12 Silkwood Close; 125 m² for \$4,500 exc. GST.

- 3. That Council be responsible for subdivision and plan registration costs.
- 4. That all parties are responsible for their own legal expenses, including any mortgage related expenses.
- 5. That any necessary documents in relation to this matter be executed under the common seal of the Council.
